This dog will be spayed/neutered prior to the age of 18 months, but not before 1 year of age. **Registration papers will be marked limited.** Limited registration precludes Buyer from showing Puppy in intact conformation shows and from registering any litters produced or sired by Puppy. Said registration entitles buyer to register puppy with AKC/ASCA and attend sanctioned obedience and agility trials.

**HEALTH GUARANTEE**

*(These guarantees are good until the puppy is 26 months of age, then all guarantees are null and void)*

- This dog, to the best knowledge of the seller, is in sound health and free from communicable diseases at the date of sale.
- Seller guarantees that Puppy is in good health and has received appropriate medical inoculations and care including parvo inoculations and worming. Seller will provide Buyer with a medical chart detailing treatment Puppy has received under Seller's care and future care Seller feels is essential to Puppy's well-being. Seller guarantees that Puppy is free of life threatening diseases or disabilities (i.e. parvo, etc.) for 48 hours after delivery to Buyer. Should life threatening diseases or disabilities be discovered by Buyer within 48 hours of receipt of Puppy, and attested to in writing to Seller by Buyer's veterinarian, Seller will provide Buyer with a replacement puppy of the same sex and color as soon as such a puppy is available to Seller. Seller strongly recommends that Buyer have Puppy examined by a licensed veterinarian of Buyer's choice within 48 hours of receipt of Puppy. The Buyer will pay all shipping costs related to the replacement dog.
- This dog is guaranteed against Hip Dysplasia. OFA Evaluation (by an X-ray taken by a qualified veterinarian) must be done no sooner than 24 months and no later than 26 months. OFA grading of Excellent, Good, or Fair are considered acceptable. (Must be rated by OFA). Less than Fair will be replaced.
- This dog is guaranteed against congenital eye defects that would be debilitating to dog's quality of life. (Verified by a veterinary Ophthalmologist)
- If this dog exhibits any or all of the above defects (verified by a vet) prior to its second birthday, a replacement dog will be given to the purchaser in exchange for said dog's registration papers and certification that said dog has been neutered or destroyed. If said dog is to be destroyed, guarantee is valid only if the seller gives prior approval. Seller will replace puppy within one year with an equal quality or better puppy of the same color and sex.
- All shipping costs for dogs replaced for any reason will be the responsibility of the Buyer.
- This dog's registered name shall contain **OLD WEST** at the beginning of the name, no other prefix or suffix will be used unless written permission from **OLD WEST** is obtained.
- Seller retains the right of first offer of purchase should the purchaser decide to sell said dog for any reason at a later date. Seller will notify **OLD WEST** in writing. Purchase price shall be no more

than the price paid to the seller on the above date. If this pup is sold, this contract becomes null and void.

**OLD WEST RESERVES THE RIGHT** to reclaim the pup named in this contract at any time for any of the following reasons:

- a.) Poor care of the pup/dog's physical health and/ or
  - b.) improper fencing/chaining the dog to any object and/or physical brutality to the dog and/or
  - c.) It is realized the offspring of this dog are being sold in a retail store, puppy mill, or auction.  
**If it should become necessary to reclaim the pup for any reasons there will be no compensation to the Buyer and all registration papers and rights of ownership will be released by the Buyer to the Seller.**
- **OLD WEST** makes no guarantee that this dog will attain Championship, Obedience, or Stock titles, as care, upbringing, training and handling methods needed to achieve the above titles are beyond our control.
  - **ASCA/AKC Limited** Registration Papers will be furnished to the puppy Buyer upon clearance of all funds due and payable to Seller. The final payment for the puppy is due in cash when the puppy is picked up.
  - **OLD WEST** will supply the Buyer with complete health records of the dog. We will supply a complete pedigree and OFA evaluation numbers of sire & dam.
  - If either party is forced to take legal action to enforce any part of this contract, action shall be initiated in the county of Seller's residence, and any legal fees and court costs shall be the responsibility of the party found to be in default.
