Hereinafter referred to as "Buyer" and Kitsy Seveland of Old West Australian Shepherds Hereinafter referred to as "Seller" voluntarily enters into and agrees to all terms delineated in this contract as witnessed by their signatures below.

I.) Buyer understands that Puppy has been sold with **LIMITED American Kennel Club (AKC) and Australian Shepherd Club of America (ASCA) registration**. Limited Registration means that the dog is registered but no litters produced by that dog are eligible for registration.

II.) Buyer agrees to take all measures necessary to insure that Puppy is not mated, and does not have the opportunity to sire or deliver a litter or litters.

III.) Buyer agrees that Puppy will be spayed/ neutered within 2 years after purchase . Please do NOT spay/ neuter before 1 year of age.

HEALTH GUARANTEE (*These guarantees are good until the puppy is 26 months of age, then all guarantees are null and void*)

I.) Seller guarantees that Puppy is in good health and has received appropriate medical inoculations and care including parvo inoculations and worming. Seller will provide Buyer with a medical chart detailing treatment Puppy has received under Seller's care and future care Seller feels is essential to Puppy's well being.

II.) Seller guarantees that Puppy is free of life threatening diseases or disabilities (i.e. parvo, etc.) for 48 hours after delivery to Buyer. Should life threatening diseases or disabilities be discovered by Buyer within 48 hours of receipt of Puppy, and attested to in writing to Seller by Buyer's veterinarian, Seller will provide Buyer with a replacement pet quality puppy of the same sex and color as soon as such a puppy is available to Seller. Seller strongly recommends that Buyer have Puppy examined by a licensed veterinarian of Buyer's choice within 48 hours of receipt of Puppy.

III) This animal is being sold on the following terms and conditions:

Seller hereby guarantees that said dog is free from the following:

- The canine disease of hip dysplasia. If said dog is found to be **severely** dysplastic (by an x-ray taken by a qualified veterinarian no sooner than 24 months and no later than 26 months and rated as severely dysplastic by O.F.A.). OFA grading of anything other than severely dysplastic is acceptable for non- breeding quality animals.
- b. Any blinding hereditary eye defects. (Upon examination by a qualified veterinary ophthalmologist)
