**This animal is being sold on the following terms and conditions:**

1. Seller hereby guarantees

that said dog is free from the following:

**A** The canine disease of hip dysplasia. If said dog is found to be dysplastic (by an x-ray taken by a qualified veterinarian no sooner than 24 months and no later than 26 months and rated as dysplastic by O.F.A.). OFA grading of Excellent, Good, or Fair are acceptable for breeding quality animals. Less than Fair will be replaced.

**b.** Any hereditary eye defects. (Upon examination by a qualified veterinary ophthalmologist)

**c.** Overshot or undershot bites (over 1/4 inch)

**d.** Males shall have both testicles by one year of age.

2. If said dog develops any of the above problems a replacement dog will be given to the Purchaser in exchange for said dog's registration papers and certification from a qualified veterinarian that said dog has been spayed, neutered or destroyed. If said dog is to be destroyed, guarantee is valid *only* if the seller gives prior approval. Seller will replace puppy within one year with an equal quality or better puppy of the same color and sex.

3. If a show/breeding quality puppy is replaced for any other reason than the disqualifications listed above, the terms shall be as follows; One half the purchase price shall be applied to another puppy. The original pup shall be spayed/neutered and the registration papers shall be returned to the seller. Seller in this contract will have the discretion to issue the registration papers on to the new owner.

4. Said dog is hereby guaranteed to be in good health and free of any illness or disease for a period of 48 hours after purchase. If said dog should require veterinary attendance within this 48 hour period, seller agrees to pay for all reasonable veterinary expenses upon receipt of a statement from attending veterinarian that the

Disease or illness was contracted during or prior to said 48-hour period. Seller demands to be notified immediately, should any illness or disease be detected

so a decision may be made on how to proceed with the veterinary treatment. If the seller is not notified IN ADVANCE of treatment, seller will not be obligated to pay veterinary expenses. This guarantee DOES NOT extend payment to payment for veterinary attendance for treatment due to negligence, mistreatment or accident to said dog, or for regular veterinary examination or shots.

5. Seller retains the right of first offer of purchase should the purchaser decide to sell said dog at a later date. If this pup is sold, all guarantees become null and void.

6. OLD WEST makes no guarantee that this dog will attain Championship, Obedience, or Stock titles, as care, upbringing, training and handling methods needed to achieve the above titles are beyond our control.

7. ASCA/AKC Papers shall be given to the Buyer when payment is received in full for the above dog, or as soon as ASCA and AKC have processed them.

*ALL guarantees shall become null and void at 26 months of age. There is no guarantee as to potency or breeding results. Breeding of this pup shall indicate that the buyer believes, to the best of their ability, that said pup is free from the genetic defects covered by this guarantee and said guarantee will be null and void.*
